#### 1. Origin:

To honor and commemorate Professor Lin Yin's academic achievements and contributions, the Ching-Yi Foundation for Culture and the Arts has established the "Ching-Yi Foundation for Culture and the Arts Scholarship." This scholarship aims to encourage students of the Department who demonstrate good character, professional dedication, and collegiality, in the hope that they will carry forward Professor Lin Yin's exemplary integration of ancient and modern scholarship.

#### 2. Eligibility:

Undergraduate and graduate students of the Department of Chinese.

## 3. Number and Amount of Scholarships:

One undergraduate student and one graduate student will each be awarded a scholarship of NT\$20,000.

## 4. Application Qualifications and Conditions:

(1) Applicants must have achieved an academic average of at least 80 or a GPA of 3.38 or above in the previous academic year. Recipients must write a letter of appreciation and submit it to the Ching-Yi Foundation for Culture and the Arts for record-keeping.

(2) Applicants must not be receiving any other scholarships (excluding the STAR Scholarship and the Academic Excellence Scholarship).

# 5. Application Period and Procedure:

- (1) Application Period: Within one month after the beginning of the second semester of each academic year.
- (2) Application Procedure: Applicants must submit a transcript meeting the academic requirements and a reflection essay (approximately 1,000 words) on the works of Professor Lin Yin. Applications must be submitted according to the Department's annual scholarship announcement.

#### 6. Review Committee and Procedure:

Applications shall be reviewed and approved by the Department's Student Affairs Committee.

#### 7. Fund Management and Usage:

- (1) The scholarship shall be managed by the University Scholarship Management Committee. Both the principal and the accrued interest shall be used for scholarship purposes.
- (2) If the principal is insufficient to cover the scholarship, the Department shall convene the Student Affairs Committee to request additional funds from the Foundation.

#### 8. Implementation and Amendment:

These guidelines shall take effect upon approval by the Department's Student Affairs Committee, ratification by the University Scholarship Management Committee, and final approval by the University President. Amendments shall follow the same procedure.
